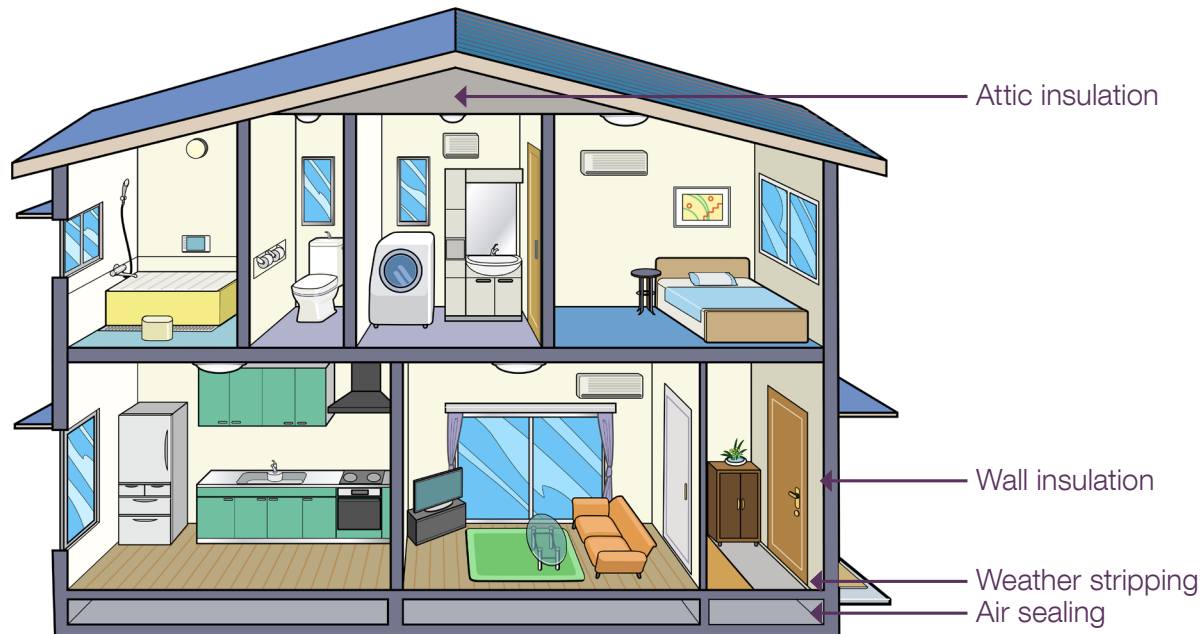


Home Weatherization Assistance

FREE home upgrades that increase comfort and lower your bill



Weatherization is the process of protecting your home so the air you heat or cool stays where you want it: inside. It helps you stay comfortable year-round and spend less on heating and cooling.

If you qualify for PSE's Home Weatherization Assistance program, you could receive thousands of dollars worth of home upgrades for free. Each project starts with a free evaluation, where we determine which upgrades your home needs. Typical projects may include insulation, so you don't lose heat, or air-sealing to keep cold air from entering your home.
